A RESOLUTION TO AMEND LOCATIONS OF YIELD INTERSECTIONS FOR THE VILLAGE OF MUKWONAGO

WHEREAS, the Village Board, based on recommendations by Village staff, has determined that it is more cost effective to amend and more administratively effective to maintain the location of yield intersections in a resolution rather than an ordinance; and

WHEREAS, some changes have been made during the transfer of the locations of yield intersections from Section 82-111 of the Municipal Code to this resolution; and

WHEREAS, the Village Judicial Committee has reviewed said locations of yield intersections and recommends amending said locations on certain streets;

NOW THEREFORE, the Village Board of the Village of Mukwonago hereby modifies such locations of yield intersections as defined in the attached schedule and be effective on December 16, 2014 and remain in effect until changed by resolution of the Village Board.

YIELD INTERSECTIONS In reference to Section 82-111 of the Municipal Code

Erection of yield signs. The supervisor of public works is authorized to erect yield right-of-way signs conforming to the Wisconsin Official Traffic Control Device Manual at the following intersections on highways in the exclusive jurisdiction of the village, provided that if the intersected highway is part of a through highway designated under Section 82-96 the provisions of W.S.A., § 349.07(7), apply:

- 1. Eastbound on Church Way Court as it intersects with Western Trail
- 2. On David Drive as it intersects with Crest View Lane
- 3. On Atkinson Street as it intersects Jefferson Street
- 4. On Wahl Avenue as it intersects with Shore Drive
- 5. Westbound on Perkins Drive as it intersects with Eastern Trail
- 6. On the following Streets as it intersects with Mukwonago Drive:
 - A. Apollo Court
 - B. Gemini Court
 - C. Mercury Court
 - D. Cernan Court
 - E. Shepard Court
 - F. Carpenter Court
 - G. Armstrong Court
 - H. Gordon Court
 - I. Lovell Court
- 7. On Division Street as it intersects with Grand Avenue
- 8. Northbound STH 83 to eastbound E. Wolf Run
- 9. Northbound STH 83 to eastbound Holz Parkway
- 10. Westbound E. Wolf Run to northbound STH 83
- 11. East drive of Park & Ride Lot at one way eastbound bus/service drive of Park & Ride lot (191 Holz Parkway)
- 12. Northbound STH 83 to eastbound CTH NN
- 13. West exit from 605 W. School Road (Mukwonago High School) to eastbound CTH NN
- 14. Southbound CTH EE to westbound CTH NN
- 15. East Troy Railroad crossings on the following locations:
 - A. CTH ES
 - B. Bayview Road
 - C. CTH J
